

**Patient Assessment and Airway Management

Perform a history and comprehensive physical exam on various patient populations; establish and /or maintain a patient airway; demonstrate oxygenation and ventilation of a patient; differentiate respiratory distress, failure and arrest; and interpret results of monitoring devices.
