

**Emergency Medical Technician  
EMSP1060**

**Course Description:**

A health-related work-based learning experience that enables the student to apply specialized occupational theory, skills, and concepts. Direct supervision is provided by the clinical professional.

**Semester Hours Credit:** 7.2 CEU hours

**Lecture/Lab Hours:** 72 hours lab

**Prerequisite:** Admission to Coastal Bend College and declaration of a health science major. Proof of Immunization, and criminal background check.

**Student Learning Outcomes:** The student will demonstrate effective Social Responsibility at 95% when identifying the components of vital signs by the end of exam 4 chapter 11.

**End of Course Outcomes:**

**Evaluation Methods:**

Weekly Quizzes: Lectured material 15%

Exams: Major 25% and Final 25%

Student Lab: practice assignment and skills exercise 15%

Clinical Practical: completion of clinical hours 20%

The Fair Use Doctrine outlines exceptions to this Law and is outlined in Coastal Bend College Policy, CT (Legal).
