Course Description: Advanced concepts of instruction in a cosmetology program. Topics include demonstration, development, and implementation of advanced evaluation and assessment techniques.

Semester Hours Credit: 4

Lecture/Lab Hours: The class meets for two (2) lecture hours and six (6) lab hours per week.
