Course Description:	Application of advanced level nursing skills and competencies in a variety of health care settings utilizing the nursing process as a problem-solving tool.
End-Of-Course Outcomes:	Demonstrate safe and competent advanced nursing skills; implement the steps in the nursing process and describe how each step relates to nursing care; and discuss the implementation of advanced nursing skills in a variety of health care settings.

Prerequisite:	Admission into Vocational Nursing Program after successful completion of all first semester courses with a Grade of C or better.
