Course Description: A chronological analysis of the historical and cultural contexts of the visual arts from prehistoric times to the 14th century.

Semester Hours Credit: 3

Course Learning Outcomes:

Upon successful completion of this course, students will:

1. Identify and describe works of art based on their chronology and style, using standard categories and terminology.
2. Investigate major artistic developments and significant works of art from prehistoric times to the 14th century.
3. Analyze the relationship of art to history by placing works of art within cultural, historical, and chronological contexts.
4. Critically interpret and evaluate works of art.

Evaluation Methods:

1. Attendance – total of no more than three (3) absences, excused or unexcused, unless granted by special permission from the instructor. Without granted special permission, more than three (3) absences reduces the final grade for the semester and more than five (5) absences results in a drop from the course.
2. Participation in class discussion noted periodically by instructor.
3. A term report, resulting from individual research, in area of student's interest.
4. Tests will consist of the following:
 - a. SLIDE IDENTIFICATION
 - i. Culture, artist, title of work/date/dates of work
 - b. MATCHING ART TERMS
 - c. QUESTIONS –multiple choice—covering the text and lectures, essay questions covering text and lectures.
