Medical Insurance POFM1327

Course Description: Survey of medical insurance including the life cycle of various claim forms, terminology, patient relations, and legal and ethical issues.

Semester Hours Credit: 3

Lecture/Lab Hours: 2/3

Prerequisite: HITT 1305, 1401 or equivalent training

Student Learning Outcomes:

Upon successful completion of this course the student will:

- 1. Compare and contrast insurance plans; define various health care delivery systems; bill patients and insurance carriers for medical services; and produce insurance claim form.
- 2. Introduce information about major insurance programs and federal healthcare legislation.
- **3.** Provide a basic knowledge of national diagnosis and procedure coding systems.
- **4.** Accurately process health insurance claims.
- **5.** Simplify the process of completing claims.
