Course Description: Preparation for certification as a Emergency Medical Technician (EMT)

Semester Hours Credit: 17.6 CEU hours

Lecture/Lab Hours: 70% lecture and 30% lab

Prerequisite: Admission to Coastal Bend College and declaration of a health science major. Proof of Immunization, and criminal background check.
